- I will be appropriately dressed at all times, following dress codes and guidelines of state FCCLA.
- I will not leave the group unaccompanied. I will advise my adviser of my whereabouts at all times.
- I will not have a member of the opposite sex in my room unless an adviser or adult chaperone and/or parent is present.
